The tenure of these officers shall be one year. in addition there shall be four Councilors elected by the active membership. He shall assume the duties of the President in the absence of the President and of the First and Second Vice Presidents.</p> <p style="text-align: center;">Sec. 7</p> <p>The duties of the Treasurer shall be to keep all funds and collect and disburse all moneys on behalf of the Society and shall keep an account of all monetary transactions and shall be responsible for their correctness. <p style="text-align: center;">ARTICLE VII</p> <p style="text-align: center;">Dissolution of Society</p> <p style="text-align: center;">Sec. 1.</p> <p>The Society shall not be dissolved, except with the consent of not less than three-fifths of the members of the Society for the time being resident in Singapore, either in person or by proxy at a general meeting convened for the purpose, or by postal vote.</p> <p style="text-align: center;">Sec. 2</p> <p>In the event of the Society being dissolved, all debts and liabilities legally incurred on its behalf shall be fully discharged and the remaining assets and funds, if any, shall be transferred to a bona fide society or societies or other approved organizations having objects similar to those of the Society.</p>	<p>Except as otherwise required by law or this Constitution, members eligible to vote at General Meetings may vote in person or by proxy. This consent may be acquired either in person, or by proxy at a general meeting convened for the purpose, or by way of postal vote.</p> <p style="text-align: center;">Sec. 2</p> <p>In the event of SEAPEX being dissolved, all debts and liabilities legally incurred on its behalf shall be fully discharged and the remaining assets and funds, if any, shall be transferred to a bona fide society or societies, or other approved organizations having professional objectives similar to those of SEAPEX.
