

SEAPEX, the SouthEast Asia Exploration Society, is a non-profit professional organization, based and registered in Singapore. Its members, recruited worldwide, are geologists, geophysicists and other professionals involved in the Earth Sciences with particular emphasis on petroleum and natural gas exploration, development and production in Southeast Asia. Professionals from areas other than the Earth Sciences and related disciplines, with an interest in the "upstream" sector of the oil and gas industry are welcome to join SEAPEX as Associate members.

SEAPEX holds meetings in Singapore in the afternoon of every second Friday of every second month (February, April, June, August, October, and December). These meetings consist in a social gathering and a 45-minute presentation on a topic related to the "upstream" sector of the oil and gas industry. Members and non-members are welcome to the SEAPEX meetings

SEAPEX meetings are held on the same day as the Singapore Scout Check Meeting, which attracts representatives from more than 100 oil and gas member companies operating in the region.

SEAPEX provides a monthly e-bulletin service and has a website, www.seapex.org, where members are kept informed of the dates and programs of forthcoming events, and of meetings organized in Bangkok, Kuala Lumpur, Jakarta, Ho Chi Minh City, Manila, Perth, London and Houston by correspondent groups of SEAPEX.

Student Membership Qualification

Students currently studying for a petroleum related degree in geology, geophysics or other earth science related degree at an accredited Southeast Asia/Australasia University are eligible for Student Membership. Application for membership must be endorsed by the Course Supervisor or Department Head. Approval of applications must receive 2/3 majority vote of **SEAPEX Council**. Membership is for a one year term, renewed annually upon proof of a valid student ID. Student Membership terminates on leaving University/taking up employment. **SEAPEX Council** may terminate a Student Membership entirely at its discretion.
